

Problematic:

Fossil oil has traditionally been the principal source of energy supply and the financing for development process in Algeria since the early years of independence, where in the context of the international transformations and the internal challenges resulting from the requirements of the sustainable development in Algeria; it has become necessary for it to trend towards developing its capacities through the exploitation of the alternative sources of energy to ensure the energy security founded on a sustainable sources and strategic collaborations that allow the full utilization of its various energy and renewable energies potential, within a forward-looking vision requires the creation of the of a legal and institutional framework aimed to ensure the energy transition and the accelerate achievement of the energy security.
